# This information sheet is to assist you in applying for Registration as an Architectural Partnership

### **Completion of Form**

- 1. To complete the Application form, you are required to refer to the attached copy of the relevant sections of the *Architects Act*
- Complete the Application Form and have your Deed of Partnership and your Certificate of Registration of your Business Name photocopied and certified as a true copy by a Commissioner of Oaths, Declarations or a Justice of the Peace.
- Provide proof of registration in the Northern Territory of the architect partner who is responsible for managing the architectural practice and supervising the provision of architectural services provided by the partnership in the Northern Territory.

#### COST

 An application fee is payable with your application, if approved, a further fee for production of your Certificate and the first year's registration will be charged.

An additional fee is payable annually for the individual architect who is:

- (a) registered in the Northern Territory; and
- (b) responsible for managing the architectural practice of the partnership in the Territory and supervising the provision of architectural services provided by the partnership in the Territory. (\*Not subject to GST)
- 5. Please make cheque payable to the Receiver of Territory Monies (RTM)

### **ANNUAL FEES**

7. Annual fees are payable for the year commencing 1 January to 31 December.

Forms are available on the web site in December each year.

Penalty for non-payment is deregistration.

### CHANGE OF ADDRESS

- During July of each year, partnerships (and companied) are required to lodge an annual return. Penalty for not lodging your return is deregistration, under section 20C of the Architects Act.
- 9. Under section 18 of the *Architects Act*, you are required to notify the Board of any change of address.

### Extracts from the Architects Act (as in force from 24 November 2004)

## Section 14A of the *Architects Act* – Qualifications for Registration as an Architectural Partnership

- The Board must authorise the Registration of an applicant as an architectural partnership where the Board is satisfied that –
  - the partnership carries on business within the Territory under the names of the partners or a name registered under the Business Names Act;
  - (b) at least one of the partners of the partnership is an architect and will be responsible for managing the architectural practice of the partnership in the Territory and supervising the provision of architectural services provided by the partnership in the Territory; and
  - (c) if the partnership includes a company amongst its partners the company is an architectural company.

### Section 19A of the Architects Act

#### **Annual Statement**

- An architectural partnership (and an architectural company) shall in the month of July in each year lodge with the Board an annual statement in the form approved by the Board. Forms are available on the website.
- 2. The annual statement referred to in subsection (1) shall contain:-
  - (a) in respect of an architectural company -
  - the full name and usual address of every person who on 30 June preceding the lodging of the annual statement was a member of the partnership;
  - (ii) in relation to each member, whether he/she is an architect;
  - (iii) any other matter necessary or convenient to the administration of the Act, which is indicated in the form.

(In relation to (iii) above, the Board requires the full name and address of the member of the partnership who is the architect responsible for managing the architectural practice of the company in the Territory and supervising the provision of architectural services provided by the partnership in the Territory.)
